The Meeting was called to order at 6:58 by: Jeff.

Discussion/Agenda:

Special Guest: Rose Keil, Bruce Larain, Tamye and Harvey Keil, Ben, Blake and Josh from Apm Mosquito contro, Brad Riggs Ralph and Phyllis Degesie, Tina and Bob Pipesh.

This meeting was called so if any of the 5 paying Burleigh residents had any more questions or concerns over putting the Communcation tower up on Turtle Road.

The Tower will be a 5 G so that people will have better reception than what they have or have not now. One concern was why not put it on M-65 or farther back on the property that they picked. They cannot put farther back on the property due to wetlands and that area is the better choice for reception. Fortune Wireless Inc has met all the requirements by law to put the tower up. One concerned with seeing it while mowing his lawn and what it will look like – along with his property value. Brad stated there are towers that will look like this by schools and high dollar areas.

Dave brought up that we should consider the 5 residents that are paying Burleigh township taxes as to why they do not want the tower because they do not want to see it from their homes. And we should disapprove of it for that reason. Jeff also brought up that both parties (Fortune and the residents) could sue Burleigh township for the wrong decision. So, we have decided that the tower would be great for Burleigh township residents but are concerned with the 5 residents that don't want it. So, we are going to have The Burleigh township board make the final decision to put it up or not. Note: Shelby Sheehan came in at the last minute of the meeting and stated that she was all for the tower.

Dave wanted to bring up some old news. He is upset with our attorney for not coming to a Metting about the Jake breaking and putting up signs and the Blight ordnance

Ben from Apm presented up a folder about the Mosquito control. They would charge Burleigh township \$ 41,000.00 to fog 300 acres of standing water and ditches and offer residents a backpack to do their yard. They also would come out to residents to spray yard for special events. They would spray twice a year. The 1<sup>st</sup> year the cost would come out of the general fund then if the residents want it – it wanted it could be put in a mileage for a 4-year cycle. It would cost the residents \$ 100.00 a year for this service. Ben will be at the next Burleigh meeting on May 3<sup>rd</sup> at 7 pm.

Next meeting is on May 10<sup>th</sup> at 7 pm at the Burleigh township hall. We will be discussing the solar and wind ordines and have a copy of Plainfield townships. We have invited the residents and asked how much land farmland they would like to see used.

We also brought up that maybe we should up our \$ 500. 00 for special meeting to \$ 1000.00.

We also mentioned that we are going through the old ordinance and updating them.
